### CIRCULAR

All the Scientists of CSB are notified as below:-

1. The Hon'ble Supreme Court of India while disposing of the Special Leave Petition No.11219/2012 filed by CSB (against the Orders of the Hon'ble High Court of Jharkhand, Ranchi Bench upholding the judgement of the Hon'ble Central Administrative Tribunal, Ranchi Circuit Bench) has clarified, inter alia, that the benefits of FCS are to be extended w.e.f.30.7.2001 with all consequential benefits to those Scientists who were before the Tribunal as Applicants and who were Respondents in the Special Leave Petition.
2. As regards the Assessment Interviews conducted during January 2011 under old FCS and again conducted during January - March 2012 under Modified FCS, the same have been cancelled as per the instructions received from the Ministry of Textiles vide letter No.25012/54/1999-Silk dated 29<sup>th</sup> April 2011 and letter No.25012/54/1999-Silk dated 14<sup>th</sup> June 2013. Further orders of the Ministry are awaited.

With the above clarification, all the pending representations given by the Scientists of CSB on the above referred issues stand disposed of accordingly.
